Thank you for selecting The Beach at Clayton County International Park for your group's outing. For the safety and enjoyment of everyone visiting The Beach, the following group and safety guidelines will be strictly enforced.

GROUP LEADER MUST:

Make a reservation. Return the reservation request form signed by group leader. Reservations will be subject to space availability and staffing. We will confirm your reservation via return fax, email or phone call. We must have this form signed prior to your groups' admission. Cash and credit card payments accepted at the Nassau Building.

Ensure that all adult members of your group have been informed of these guidelines, policies and procedures. Your group or individual members of your group are subject to removal from the park or may be refused admission if these policies are not followed. SAFETY is our Number One Priority. Please work with us to have a wonderful and safe experience at "The Beach".

CHAPERONES:

Children 12 years of age or less must be accompanied by an adult chaperone. **Adult chaperones must be at least 16 years old.** One adult chaperone is required for every five children ages 3-12. Cost for beach entrance for ages 3-12 is \$9.00 and allows one complimentary pass per 5 children with a maximum of 20 complimentary chaperones. The cost for beach entrance for ages 13+ is \$11.00 and allows one complimentary pass per 10 adults with a maximum of 20 complimentary Passes. Any additional adults will be charged \$11.00 for entrance to The Beach. Children age two and under require one paid adult chaperone per child. Complimentary rule does not apply. (Please note: The complimentary Passes only apply for Group Outing Request)

Group members must AT ALL TIMES stay with their groups, maintain the required child/chaperone ratio and wear armbands in and out of the beach area. Lifeguards and staff will ask unattended children to exit beach, slide area and kiddie adventure pool until a chaperone is found. Teens and unsupervised children are not allowed in kiddie adventure pool. Teens supervising children will be allowed in the kiddie adventure pool to observe only.

GROUP POLICIES AND PROCEDURES

GROUP USE OF BEACH

Proper swim attire is required. CHILDREN 2 YEARS AND UNDER ARE REQUIRED TO WEAR A SWIM DIAPER. *Individuals must be 12 years old or under to use the Indoor Playground and must wear armbands at all times. (Indoor Playground capacity is 40 children). Pavilions are not provided for your group's lunch. Your group may have lunch at picnic areas in the park. It will be the responsibility of the group to keep the picnic area clean. Beverages and coolers are allowed on the beach. NO glass containers or alcoholic beverages are permitted.

No outside food is allowed to be brought into the beach area. No smoking on the beach, kiddie pool area, or any location inside International Park.

LIFEGUARDS MUST BE OBEYED IMMEDIATELY AT ALL TIMES

Disrespectful conduct, such as vulgarity, offensive clothing, loud music or improper wearing of clothing, loitering, intoxication, line breaking, theft and smoking in non-designated areas will not be tolerated. All group members must follow all park and water facility rules. Chaperones and group leader must ensure that all group members understand these rules. Repeated infractions will be cause for the entire group to be asked to leave without refund. Children must be 48" or under to be in kiddie pool. Rider restrictions for lake slides are posted at the bottom of each slide.
